

**IMPORTANT INSTRUCTIONS REGARDING B.DES RESULT ANNOUNCEMENT & SUBMISSION OF CAMPUS PREFERENCE**

<b>Result Announcement</b>	Monday, 04 July 2022 (6 PM)
<b>Submission of Campus Preference</b>	04 - 06 July 2022
<b>Confirmation of Seat, Payment of Non-Refundable Fees &amp; Uploading of Documents</b>	09 - 10 July 2022

It will be the sole responsibility of the candidates to check for updates on the admissions website from time to time for the given days and confirm their seat before the given deadline. It may also be noted that all further communications, if any, from NID will be sent to the registered email ID of the candidate as provided at the time of applying online.

**STEP 1: VIEWING OF B.DES FINAL RESULT**

The candidates can view their result by entering their login credentials.

**STEP 2: SUBMISSION OF CAMPUS PREFERENCE**

After viewing their result, the candidate will be asked to submit his/her campus preference, based on the availability of the seats and in the order of merit, in the respective category and campus. The candidate can modify the selection multiple times between **04 to 06 July 2022**. **The last selection of the campus, after the deadline, will be considered as final.**

**If the candidate fails to submit his/her campus preference during the given period, he/she will lose the chance to proceed further in the Admissions process. It will be considered that the candidate is not interested to opt for any seat; and his/her seat will be offered to the next candidate in order of merit in the respective category. Such candidates cannot participate in subsequent admissions process.**

**STEP 3: ROUND -01- SEAT ALLOTMENT**

Based on the preference, in order of merit and number of available seats, category-wise, the candidate will be provisionally allotted a seat in the campus selected by him/her. In order to confirm the seat, the candidate will be provided with a window, as per the schedule mentioned above, for (a) making a payment of NON-REFUNDABLE Fee for the confirmation of seat and (b) Uploading of the documents, within the provided time-limit as mentioned above.

**Obtaining a rank in the merit list does NOT guarantee admission to the B.Des programme.**



**Payment of NON-REFUNDABLE Fee for the confirmation of seat:**

- a. INR 30,000/- (online payment) + Convenience Charges (as applicable) for GEN, GEN-EWS, OBC-NCL, SC, ST, PwD candidates;
- b. INR 75,000/- (online payment) + Convenience Charges (as applicable) for Overseas candidates.

**Documents to be uploaded:**

**The candidate will have to upload the following documents as a single pdf file of size not more than 10 MB:**

1. Any one valid photo identity (Aadhar Card, Election ID, Driving License, PAN Card/Valid Passport)
2. Birth Certificate **OR** School Leaving Certificate
3. 10th Mark-sheet
4. 12th Mark-sheet\* (in case not issued, the digital copy of the same duly attested by the School Principal needs to be uploaded **OR** candidates whose Class 12 results are awaited will have to upload the bonafide certificate {format available on the admissions website} issued by the Principal of the School {last attended} clearly specifying the Roll No. and expected date of announcement of the results of the qualifying examination, before the deadline)
5. GEN-EWS/OBC-NCL/SC/ST Certificate, if applicable
6. PwD Certificate, if applicable
7. Valid Passport, if applied under Supernumerary (Overseas) category\*\*

*\*Candidates who have completed final examinations for class XII (or equivalent) outside India or from a Board not specified in the Admission Handbook 2022-23 must produce an equivalence certificate (check Admissions Handbook 2022-23 for detailed information).*

*\*\* The candidates who have applied under Overseas category should produce a valid passport. It is the candidate's responsibility to obtain relevant visas and ensure that their passport is valid till the duration of the programme.*

If the candidate fails to make the payment of the NON-REFUNDABLE Fee for the confirmation of seat within the given period as mentioned above, the provisional allocation of seats will be cancelled, and the seat will be allotted to the next qualifying candidate in the order of merit. Such candidates cannot participate in the subsequent admissions process.

If the candidate fails to upload the documents within the given period as mentioned above, even after making the payment of the NON-REFUNDABLE Fee, the provisional allocation of seats will



be cancelled, and the seat will be allotted to the next qualifying candidate in the order of merit. Such candidates cannot participate in the subsequent admissions process.

**STEP 4: DOCUMENT VERIFICATION**

1. Uploaded documents will be verified against the information provided by the candidate in their Application Forms, at the time of applying online, by the respective NIDs.
2. Upon verification, if the documents are found to be incorrect/invalid, the candidature of such candidates will stand cancelled, and that seat will be allotted to the next qualifying candidate in the order of merit in their respective category.

**STEP 5: ISSUE OF PROVISIONAL OFFER-LETTERS OF ADMISSION**

Based on the merit number of the candidates and availability of seats, Provisional Offer-Letters of Admission will be issued to those candidates whose uploaded documents have been verified and found to be correct, by the respective NIDs.

The payment of the remaining fees would be communicated to the candidates by the respective NIDs directly wherein the candidate is provisionally admitted.

**STEP 6: ROUND-02 – SEAT ALLOCATION**

The seats remaining vacant after Round 01 of Seat Allotment will be opened for allotment of seats in Round 02, the dates for which shall be intimated later by the respective NIDs.
