

IMPORTANT INSTRUCTIONS REGARDING M.DES RESULT & SEAT ALLOTMENT

Payment of Non-Refundable Fee for the confirmation of seat & uploading of documents	05 – 07 July 2022

It will be the sole responsibility of the candidates to check for updates on the admissions website from time to time for the given days and confirm their seat before the given deadline. It may also be noted that all further communications, if any, from NID will be sent to the registered email ID of the candidate as provided at the time of applying online.

STEP 1: VIEWING OF M.DES FINAL RESULT

The candidates can view their result by entering their login credentials.

STEP 2: ROUND-01 - SEAT ALLOTMENT

Based on the availability of the seats, the shortlisted candidates will be allotted a seat in the order of merit in their respective category. Such shortlisted candidates will have to confirm their seat by (a) making a payment of NON-REFUNDABLE fees for confirming their seats and (b) Uploading the documents, within the provided time-limit.

The allotment of the seats will be purely based on the preferences of the discipline, submitted by the candidate **at the time of applying online.**

In case a candidate has applied in two disciplines and gets shortlisted in both the disciplines, then the candidate will be allotted a seat in the discipline marked as first preference ONLY and their seat in the discipline marked as preference 02 will be allotted to the next candidate in order of merit. Such candidates will not be able to claim their seat (in the discipline marked by them as preference 02) at any later stage of the admission process.

In case a candidate has applied in two disciplines and gets shortlisted in only the discipline marked by them as preference 02, then the candidate will be allotted a seat in the discipline marked by them as preference 02.

In case a candidate has applied in two disciplines and is eligible in both the disciplines but gets shortlisted only in the discipline marked as Preference 02, the candidate will be allotted a seat in the discipline marked as Preference 02. If a vacancy arises in the discipline marked as Preference 01, then by default, the candidate will be allotted a seat in the discipline marked as Preference 01, based on the merit. The seat of such a candidate in the discipline marked as Preference 02 will then be offered to the next candidate in the order of merit and preference.

Obtaining a rank in the merit list does NOT guarantee admission to the discipline of your choice in M.Des programme.



If the candidate fails to confirm the seat or make the payment of the NON-REFUNDABLE Fee within the given period as mentioned above, the provisional allocation of seats will be cancelled, and the seat will be allotted to the next qualifying candidate in the order of merit and availability of seats in their respective category.

STEP 3: PAYMENT OF NON-REFUNDABLE FEE FOR THE CONFIRMATION OF SEAT:

- a. INR 30,000/- (online payment) + Convenience Charges (as applicable) for GEN, GEN-EWS, OBC-NCL, SC, ST, PwD candidates;
- b. INR 75,000/- (online payment) + Convenience Charges (as applicable) for Overseas candidates.

STEP 4: UPLOADING OF DOCUMENT:

The candidate will have to upload the following documents as a single pdf file of size not more than 10 MB:

1. Any one valid photo identity (Aadhar Card, Election ID, Driving License, PAN Card, Passport)
2. Birth Certificate **OR** Proof of Date of Birth **OR** School Leaving Certificate
3. 10th Mark-sheet
4. 12th Mark-sheet
5. Semester wise Marksheet **OR** Consolidated Transcript of Graduation/Diploma Programme*
6. Graduation Certificate/Provisional Degree Certificate/Bonafide Certificate (in case the qualifying examination has not been conducted or the final results are awaited*).
7. GEN-EWS/OBC-NCL/SC/ST Certificate, if applicable
8. PwD Certificate, if applicable
9. Valid Passport, if applied under Supernumerary category**

** Candidates whose qualifying examination has not been conducted or the results are awaited must upload the bonafide certificate (format available on the Admissions website) issued by the Principal/Dean of the College (last attended) clearly specifying the Roll No., expected date of examination or expected date of announcement of the results of the qualifying examination, before the deadline for the payment of NON-REFUNDABLE token fees. If the Degree Certificate is awaited, the candidates will have to upload a Provisional Degree Certificate.*

****** The candidates who have applied under Overseas category should produce a valid passport. It is the candidate's responsibility to obtain relevant visas and ensure that their passport is valid till the duration of the programme.



NOTE: Candidates who have completed or will be completing their Degree (or equivalent) from outside India or a University not specified in the Admissions Handbook 2022-23 should produce an equivalence certificate (check Admissions Handbook for detailed information).

If the candidate fails to make the payment of the NON-REFUNDABLE Fee for the confirmation of seat within the given period as mentioned above, the provisional allocation of seats will be cancelled, and the seat will be allotted to the next qualifying candidate in the order of merit. Such candidates cannot participate in the subsequent admissions process.

If the candidate fails to upload the documents within the given period as mentioned above, even after making the payment of the NON-REFUNDABLE Fee, the provisional allocation of seats will be cancelled, and the seat will be allotted to the next qualifying candidate in the order of merit and availability of seats in their respective category. Such candidates cannot participate in the subsequent admissions process.

STEP 5: DOCUMENT VERIFICATION

Uploaded documents will be verified against the information provided by the candidate in their Application Forms, at the time of applying online.

Upon verification, if the documents are found to be incorrect/invalid, the candidature of such candidates will stand cancelled, and that seat will be allotted to the next qualifying candidate in the order of merit.

STEP 6: ISSUE OF PROVISIONAL OFFER-LETTERS OF ADMISSION

Based on the merit and availability of seats, Provisional Offer-Letters of Admission will be issued to those candidates whose uploaded documents have been verified and found to be in order.

The Round 02 of Seat Allotment (on vacant seats) would be communicated to the next candidates in order of merit in the respective category on their registered email id.
