# 1. General Information

National Institute of Design (NID) is an 'Institute of National Importance' as per the NID Act 2014, as well as an autonomous Institute under the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce & Industry, Government of India. The Institute is empowered to award its own degrees and presently offers Bachelor of Design (B.Des.), Master of Design (M.Des.), and Doctor of Philosophy (PhD) in Design. The Institute is also a member of the Association of Indian Universities (AIU). It has strong linkages with the industry and active collaboration with several Design institutes and universities across the world.

In pursuit of its continued commitment to Design research, NID started a PhD Programme in Design in the year 2017.

In the year 2022 NID entered into an agreement with Lucerne University of Applied Sciences and Arts - School of Design, Film and Art (HSLU), Switzerland, to offer a **NID-HSLU PhD Cooperation program** separate from its own PhD program alluded to above, on the theme *Eco-Social Innovation by Design*. This program is open to people worldwide to apply. A common portal is used for application to both programs.

# PhD in Design at NID

Design is the professional capability of creating and developing context-led concepts and translating them into tangible solutions for the benefit of people, society, industry and the environment. The design of objects, communication, services, interface and their systems requires in-depth analysis and the creative synthesis of information and ideas based on a variety of disciplines and experiences. Design thinking brings together the finest sensibilities of the arts, the logic of science and the functional pursuits of technology in an innovative framework.

At the heart of all of NID's academic programmes and activities are the values of 'learning by doing' and 'learning from the field'. The curriculum and pedagogy at Bachelor's and Master's levels offered at the Institute have uniquely evolved from a value based interdisciplinary approach to creative problem solving wherein research is integral to the process of design.

NID's Doctor of Philosophy (PhD) degree in Design shall be awarded for an advanced and detailed in-depth research study of any particular aspects of Design that the candidate feels have hitherto not been studied and which culminates with a thesis that extends the body of knowledge and the application of design thinking, process and practice. In the case of a practice-based PhD, such work might be centred around a creative outcome of the candidate's professional practice.

The programme is open to educators and professionals in Design and allied creative fields who wish to undertake theoretical study of their own practice or knowledge base and push the boundaries of the discipline.

Doctoral students of NID's PhD Program would be eligible to access and use facilities of all campuses of NID: Ahmedabad, Gandhinagar, and Bangalore.

### **NID's PhD Cooperation Program with HSLU, Switzerland**

Apart from its regular India-based doctoral program, NID is part of a doctoral program it offers in collaboration with HSLU, Switzerland (referred to henceforth as the "**NID-HSLU PhD Cooperation Program**"), where students pursue research on the theme Eco-Social Innovation in Design and are entitled to use the academic infrastructure of both NID in India and HSLU in Switzerland.

The NID-HSLU PhD Cooperation program has set itself the goal of jointly addressing selected topics at the doctoral level, which necessarily must be approached from different cultural, economic, creative and design perspectives, and which address the overarching **theme of sustainability**.

The purpose of the programme is to support the creation of products, services or systems that foster change to improve the life quality of people, meet demands to sustain the environment, improve policymaking; and better the understanding and use of design both in the industry and the public sector, education, and society at large. Hence, the overarching topic to be addressed in this cooperation is eco-social innovation, addressed from the perspective of the existing research areas and ongoing research activities of both partners.

Doctoral students of the NID-HSLU PhD Cooperation Program commit themselves to a certain defined coursework at NID (at least one module<sup>1</sup>), whereby parts can also be mutually compensated with offers from HSLU. All new doctoral students commit themselves to attend the introductory module in person and on-site at NID in the first semester of the programme. Courses offered in English at HSLU can be taken by all doctoral students, whether they study at HSLU or at NID. When proving good command in German language, courses held in German can be taken as well.

Doctoral students of the NID-HSLU PhD Cooperation Program would be eligible to access and use facilities of both institutes—NID in India (Ahmedabad, Gandhinagar, and Bangalore) and HSLU in Switzerland.

Application to the NID-HSLU PhD Cooperation Program must be made through the same portal as for NID's program. The interface allows the user to indicate which program they are applying for.

**The fees of the NID-HSLU PhD Cooperation program are different from the fees of NID's doctoral program.**

## 2.1 Aims and Goals

NID's PhD programme in Design aims to promote deep reflection, inquiry, and rigor in the development and dissemination of new ideas, expressions and skills in the field of Design and allied fields and shall lead to their meaningful manifestations in the form of new design collections, objects, communication, services, strategies, etc. The work shall contribute new theories and knowledge to Design, Design education and Design practice.

The purpose of the programme is to better the understanding and use of Design in industry, education and society at large.

## 2.2 Objectives

1. To foster original research and create new knowledge about the nature and practice of Design.
2. To engage in a deeper understanding of expressions, methods and the role of Design in problem-solving activity.
3. To foster NID's pedagogic principles of 'Learning to Know' and 'Learning to Do' .
4. To enable collaboration in research, scholarship, Design development and service.
5. To enable students to engage in advanced research and practice with Design theorists and practitioners in a broad variety of fields.
6. To contribute towards the Institute's objective of Design for dignity and service to society, and to participate in meaningful Design for change and sustainability.

## 2.3 Practice- vs Theory-led Doctoral Research in Design

The PhD programme in Design may be undertaken in one of the modes given here:

**Practice-led Research:** Original investigation undertaken in order to gain new knowledge partly by means of practice and the outcomes of that practice. Such research includes practice as an integral part of its method and often falls within the general area of action research outcomes. Creative outcomes may be in the form of artefacts such as objects, images, film, fashion, music, Design collections, models, samples, prototypes, digital media, performances and exhibitions or other outcomes. The doctoral submissions for this kind of research must include contextualisation of the creative work.

**Theory-led Research:** It would be concerned with the nature of practice and lead to new knowledge that has operational significance for that practice. The main focus is to advance knowledge about practice, or to advance knowledge within practice. Such research may be fully described in text form in the doctoral thesis, without the inclusion of a creative outcome.

## 2.4 Part-time vs Full-time engagement

The PhD programme is allowed to be taken up in part-time or full-time formats.

### Full-time PhD

**Residence:** Full-time candidates are required to be present on campus throughout the duration of their doctoral study period.

**Duration:** The maximum duration allowed for a full-time candidate is 3 years, which can be extended upto 5 years upon formal application by the candidate and endorsement by their guide and co-guide.

**Eligibility for financial support:** Occasionally the Institute might make announcements of financial support if sources make such support available. On such occasions only full-time candidates are eligible to apply for the support.

### Part-time PhD

**Residence:** Part-time candidates are required to be present on campus for the duration of scheduled coursework, seminars, and other academic requirements that are declared to be held in person.

**Duration:** The maximum duration allowed for a full-time candidate is 5 years, which can be extended upto 7 years upon formal application by the candidate and endorsement by their guide and co-guide.

**Employer's No-Objection Certificate:** Working professionals in employment elsewhere and seeking admission to the part-time PhD programme are required to obtain a No-Objection Certificate (NOC) from their employer, stating that the employer has no objection to the employee pursuing a PhD from the Institute, and that the employee will be available in person or online as the Institute may require for doctoral consultations with the guide, for all Institute coursework, periodic seminars and presentations, as the case may be, and will fulfil residential requirements as per the Institute's requirements. This certificate should be submitted no later than acceptance of offer of admission if made.

**Eligibility for financial support:** Part-time candidates would NOT be eligible for ANY financial support from the Institute.

Part-time candidates shall also be governed by all rules and regulations of the Institute.

## The SAGE PhD Fellowship

NID is pleased to offer one (1) full-time PhD Fellowship on the topic of Biopackaging through the SAGE PhD Fellows program of Echo Network of Bangalore, a Denmark-based organisation that works with the Nordic Centre of India to promote research on Sustainability. Research proposals are invited for this Fellowship opportunity.

The terms of this Fellowship are as follows:

- This Fellowship would be available for research **only on the topic of Biopackaging**. The research must also relate to the field of Design and thus make a contribution to theoretical knowledge of the two fields (Design and Biopackaging) combined. The proposals for this fellowship should center on sustainable materials, specifically targeting Eco-Friendly Biopackaging from Agricultural Residuals. This research will assess innovative design and business models aimed at shifting to sustainable biopackaging systems in the Indian industrial sector. Emphasis will be placed on sustainable materials design research and the development of implementation strategies for eco-friendly packaging solutions, ultimately contributing to enhanced rural livelihoods.
- The Fellowship would be available only to **full-time candidates**. The candidate would be required to **fulfil physical attendance requirements at NID's Ahmedabad campus** for the entire duration of their doctoral study.
- The Fellowship is available only to applicants of NID's PhD program, not to applicants of the NID-HSLU Cooperation program.
- The Fellowship would be available for **three (3) years**. If more time is required for the research work to be completed, the candidate could apply for it (extending the duration upto a maximum of 5 years) but the duration of funding is limited to 3 years.
- The fellowship would include a stipend for living expenses in Ahmedabad, tuition fees of the PhD program, and all costs (eg, travel, conferences, material) related to the research being conducted.
- The candidate on this Fellowship is required to **spend up to 7 months in Denmark** (over the three-year Fellowship period) working with Danish institutes associated with Echo Network on this project. The costs of this would be covered in addition to the fellowship.
- Applicants to this Fellowship must clearly **include the following in the title of their research proposals: "Application for SAGE Fellowship"** to indicate their intent of applying for the fellowship. Absence of this phrase in the title would be taken to mean that the applicant does not wish to be considered for the fellowship even if the topic is related to Biopackaging.
- Only **one (1) position is available** for the Fellowship.
- Applicants for the Fellowship would **go through the same Admissions process as that published in the Admissions Handbook** for 2024.
- The candidate who is awarded the Fellowship would be required to **go through all the academic processes of all doctoral students of NID** during their doctoral tenure at the Institute.



# 3. Process of Selection

Entry to NID's PhD programme, with to the NID-HSLU PhD Cooperation Program and the SAGE PhD Fellowship will be granted on the basis of performance in the following four-stage selection process:

Stage 1: Screening for eligibility

Stage 2: Assessment of Research Proposal

Stage 3: Doctoral Research Test

Stage 4: Interview

These are detailed below.

## **Stage 1: Eligibility Screening**

Information in the application forms of candidates is scrutinised to ascertain whether various eligibility requirements, such as that of educational qualification, are met. Those who do not fulfil the eligibility criteria will be rejected at this stage. Those who are found eligible move on to Stage 2. The eligibility requirements are the same for both, NID's PhD programme and the NID-HSLU PhD Cooperation program.

NID also offers one full-time PhD fellowship on the topic of Bio-Packaging through the SAGE PhD Fellows program of Echo Network of Bangalore, a Denmark based organisation. This research project is pursued in collaboration with the NID PhD program (details provided in section 2.4).

These educational eligibility qualification requirements are described in detail in Section 5.1.

## **Stage 2: Assessment of Research Proposal**

Candidates are required to submit a research proposal they have formulated outlining their motivation for conducting the doctoral research they are applying for, the strength and relevance of their background for conducting the research, brief review of existing work on the topic, the relevance of their proposed research to the field of Design, the expected outcomes, and a plan to achieve them.

The proposal must be limited to two to three thousand words (20,000 characters including spaces) or less.

The content of the research proposal of the eligible candidates will be examined from the point of view of alignment with NID's research objectives, analytical content, relevance of the proposal to the broad theme of Design, the overall knowledge-creation potential of the research, and other factors.

Only candidates whose proposals pass this assessment would be shortlisted for Stage 3.

### **Stage 3: Design Research Test (DRT)**

Candidates shortlisted in Stage 2 would be required to take the Design Research Test (DRT). The DRT is framed to test the candidate's Design aptitude and research abilities, general awareness, basic numeric and Design abilities, among other factors.

Candidates who have work experience of 15 years or more are exempt from taking the DRT.

Candidates who pass the DRT would proceed to the next and final stage of selection, the Interview.

### **Stage 4: Personal Interview**

Candidates shortlisted in Stage 3 would be invited to appear for the Personal Interview, where the candidates would interact online with appointed representatives of the Institute who would assess the candidate for their aptitude for conducting the proposed research.

Among other things, the interview would assess the candidates for the following:

1. The merit of the Research Proposal for adding to new knowledge in the field of Design
2. Competence of the candidates for conducting the proposed research as assessed by their academic record and work experience and personal accomplishments in relevant areas
3. Match of the candidate's proposed research area with the published interest areas of at least one faculty member of the Institute and with the Institute's overall goals and priorities
4. Exposition of proposed research to panel, demonstrating articulation and conviction.

All submission closes at the closing of this window. New submissions or changes to submissions already made would not be allowed beyond the last date of this period.

## Note:

1. Those candidates who were rejected due to the eligibility criteria/ missing documents will be allowed to apply again provided they now meet the eligibility criteria as mentioned in the Round 2 of the PhD Admission Handbook 2024-25.
2. Those candidates whose research proposals were rejected (at the proposal review stage) will be allowed to resubmit the revised proposals to be evaluated again.
3. Those candidates whose research proposal was accepted (1st round) but failed in the DRT may be allowed directly to appear for the DRT.
4. Those candidates who had passed the DRT but failed in the interview (1st round) may be allowed to appear directly for the interview
5. Those candidates who were exempted from DRT due to 15 years of experience and who failed in the interview, may be allowed to appear directly for the interviews.
6. The candidates falling under any of the above scenarios will be exempted from paying the application fees.

# 5. Eligibility Criteria for Admission

## 5.1 Educational Qualifications

Only the following educational qualifications are eligible for admission to the PhD program:

- a. Master of Design (M.Des)<sup>2</sup> degree from an accredited institution or recognised university of India or an equivalent<sup>3</sup> foreign degree
- b. Master of Philosophy in Design (M.Phil (Design))<sup>4</sup> degree from a recognised institution or University of India or an equivalent<sup>3</sup> foreign degree
- c. Master of [Architecture/Fine Art/Applied Art]<sup>4</sup> from a recognised institution or University of India or an equivalent<sup>3</sup> foreign degree, following a [Master/Bachelor of Design degree from India or an equivalent<sup>3</sup> foreign degree]
- d. Bachelor of Design (B.Des)<sup>5</sup> degree from NID + 3 years professional or teaching experience
- e. Certificate of 2-year Faculty Development Program in Design from NID or any other recognised University

These may be followed by other academic qualifications but one of the above five is mandatory for eligibility. Candidates are requested to make sure that their qualifications match this requirement.

### For the NID-HSLU PhD Cooperation Program

The above requirements apply for admission to the NID-HSLU PhD Cooperation Program as well.

#### Note:

Candidates who are scheduled to complete the final year of their qualifying examinations and are awaiting results are also eligible to apply for the PhD programme. In such cases, their candidature shall be provisional and confirmation of selection shall be subject to successful completion of the qualifying exams. Provisional acceptance will be confirmed only if the candidates secure the minimum grade/marks in their qualifying examination and submit its results to the Institute before the commencement of the programme. Failing this, the provisional status granted to such candidates shall automatically stand cancelled.

# 6. Number, Reservation of Seats

The number of seats in NID's PhD programme for 2024-25 is **twelve (12)**, out of which one (01) seat under Open Category has been filled in Round 01 of the PhD Admissions 2024-25.

The remaining seats are open to both Indian or non-Indian citizens with the caveat that while Indian citizens may apply for either part-time or full-time engagements, **non-Indian citizens may only apply as full-time** candidates under the following restrictions<sup>6</sup>:

- a. *Foreign nationals with Indian Council for Cultural Relations (ICCR) Fellowship.* Awardees who are sponsored by their respective Governments and awarded a scholarship by the Indian Council for Cultural Relations shall apply for admission through Indian Embassy in their respective countries;
- b. *Foreign nationals who are self-financed* shall be granted admission through the Embassy of the respective Governments after approval of the Ministry of External Affairs and a no-objection certificate from the concerned Ministry of the Central Government;

In addition to these remaining seats, there are **five (5) supernumerary seats** for the following:

- **Two (2)** Supernumerary seats reserved for the Overseas category, for which **only non-Indian citizens** may apply, and **only for part-time positions**.
- **Three (3)** Supernumerary seats **reserved for applicants to the NID-HSLU PhD Cooperation Program** only, which are *open to anybody regardless of citizenship* and open to either full-time or part-time positions.
- **One (1) full-time** PhD research fellowship available under the NID-SAGE partnership framework, has been filled in the Round 01 of the PhD Admissions 2024-25.

The application fees and the tuition fees for the five supernumerary seats are different from the corresponding fees for the twelve seats in NID's PhD programme

## 6.1 Caste-based Reservation

For the 12 seats of NID's PhD Program, the Institute shall follow the Reservation policy of the Government of India for allocation of seats in the final selection of candidates for admission. At the time of this announcement, the requirement of the Reservation policy is as follows:

- Fraction of seats to be reserved for Scheduled Castes (SC): 15%
- Fraction of seats to be reserved for Scheduled Tribes (ST): 7.5%

- Fraction of seats to be reserved for Economically Weaker Section (EWS) of the General category: 10%
- Fraction of seats to be reserved for Other Backward Class (OBC)<sup>7</sup>: 27%
- The remaining fraction, *i.e.*, 40.5%, is to be filled irrespective of caste, on merit alone. This segment is termed 'Open'.

Using the fractions above the total seat capacity of 12 is divided into the following composition of seats:

\* One (01) seat has been filled in the Round 01 of the PhD Admissions Handbook 2024-25.

Non-Indian citizens are eligible to apply for admission but would not be eligible to avail of reservations. They would be counted in the Open category.

The Reservation category chosen by a candidate at the time of submitting the application form will be considered as final, and requests for change of category will not be entertained.

## 6.2 Reservation for Persons with Disability (PwD)

For the 12 seats, 5% of the total seats are reserved for Persons with Disability (PwD), irrespective of caste-category,

For the total of 12 seats, admission will therefore be granted to the top **1 (one)** of the applicants with disability, in order of merit, irrespective of their Reservation category, provided they otherwise qualify for selection.

## 6.3 Applications from non-Indian citizens

As described above, candidates holding citizenship of a country other than the Republic of India are eligible for admission to NID's PhD Program under any of the following:

- As Full-time candidates:** Non-Indian citizens who wish to join the program as full-time candidates are eligible to apply in the Open category of 5 students shown in the table above.
- As Part-time candidates:** Outside of the 12 seats mentioned earlier, 2 seats are reserved under the Supernumerary (Overseas) category for Non-Indian citizens who wish to apply as part-time students.
- As applicants to the NID-HSLU PhD Cooperation Program.** This program has no limitations of citizenship, hence, is open to applicants from any country.

# 7. How to Apply

Visit the NID website at <http://admissions.nid.edu> and follow the steps given below:

## Step 0:

Please have in mind which program you are applying for: NID's PhD program or the NID-HSLU PhD Cooperation Program. Remember that if you intend to apply for both, you will have to apply separately for each program.

Read and familiarise yourself with the eligibility criteria and other relevant information related to the PhD programme (among the above) you are proceeding to apply for. All this information can be found in this handbook and from the websites of the two institutes (NID and HSLU).

## Step 1: Sign up/Registration

1. All candidates are required to download this handbook and fill up the online application form available at <http://admissions.nid.edu>
2. Please fill up the online application form giving correct information. Provide a valid email address and an active mobile number while filling up the form, since these contacts will be used for all future communication with the applicant. Ensure that this email id and mobile number is active till 30 January 2025. Candidates will be solely responsible in case a wrong email address and/or mobile number has been provided.
3. After registration, login credentials will be sent via an email to the registered email address (do remember to check your spam or junk folders in case you do not find the email in your inbox). **In case a wrong email address and/or mobile number has been provided during sign up, you are required to register afresh with the correct details.**
4. Do not delete emails sent to you as this will be needed for future reference.
5. Log in to your account using login credentials to proceed further.

## Step 2: Fill the Online Application Form

1. Log in.
2. Fill in all the required details.
4. After filling all details, click 'Save & Proceed' to go to the next section to 'Upload Documents'.
5. Click 'Save & Exit' to complete the form at a later time.

## Step 3: Uploading Documents & Signature

1. Upload a scanned recent passport-size photograph as per instructions. All photographs must be in colour, taken at a professional studio, must be in JPG/JPEG format, and not exceeding 100 KB in size.



2. Upload your scanned signature as per the instructions. All signature files must be in JPG/JPEG format and not exceeding 100 KB in size. You should have your signature digitally photographed or scanned and cropped to the required size.
3. Indian citizens applying under the EWS category are required to upload their valid EWS Certificate issued by a competent authority, in the prescribed format as available on the website <https://admissions.nid.edu>. **The date of issue of EWS certificate must be 01 April, 2024 or later**, based on the gross annual income of the financial year 2023-24. The certificate must be in the name of the candidate and also must have the candidate's photo on the certificate. The certificate must be in PDF format and should be of maximum of 2MB in size. For certificates that are not in the English/Hindi language, the candidate is required to produce / upload a notarized copy of the certificate in English language along with the original copy of the category certificate.
4. Indian citizens applying under the OBC-NCL category are required to upload their valid OBC-NCL Certificate issued by a Competent Authority. The format of the OBC-NCL certificate should be as per the Central format (available on the website <https://admissions.nid.edu> in Download section). The OBC-NCL certificate must be **issued on or after 01 April 2024** (based on the gross annual income of the financial year 2023-24) and in the name of the candidate. The certificate must be in PDF format and should be of maximum 2 MB in size. For certificates that are not in the English/Hindi language, the candidate is required to produce / upload a notarized copy of the certificate in English language along with the original copy of the category certificate.
5. Indian citizens applying under the SC and ST categories are required to upload their valid Caste Certificate issued in their name by a Competent Authority. For certificates that are not in the English/Hindi language, the candidate is required to produce / upload a notarized copy of the certificate in English language along with the original copy of the category certificate. The certificate must be in PDF format and should be of maximum 2 MB in size.
6. Indian citizens applying under the Persons with Disability (PwD) category are required to upload their valid Disability Certificate issued by a Competent Medical Authority as per the guidelines of the Government of India (format of which is available on the website <https://admissions.nid.edu>) along with the Unique Disability Identity Card. The certificate must be in PDF format and should be of maximum 2 MB in size.
7. Applicants of non-Indian citizenship are required to upload the first and last page of their valid passport in JPG/JPEG format, clearly showing all of their personal information. The candidate must ensure that the passport is current (not expired) at the time of applying online. The certificate must be in PDF format and should be of maximum 2 MB in size.
8. **Upload Research Proposal attachments in ONE SINGLE PDF FILE not exceeding 5 MB in size.**
9. **Upload certificates of graduation (Bachelors), post-graduation (Masters), any additional qualifications, work experience certificates** (as per the information provided during filling up the application form) in ONE SINGLE PDF FILE not exceeding 10 MB in size.

Persons applying under PwD category need to furnish a Disability Certificate and Unique Disability ID issued by the Department of Empowerment of Person with Disability in addition to documents in their caste category above.

# Appendix

## Appendix A: Caste-based Reservation

Candidates belonging to the EWS, OBC-NCL, SC, ST and PwD categories will be declared as qualified on the basis of the minimum qualifying criterion as mentioned in the handbook.

Unfilled seats based on minimum qualifying criterion mentioned in this handbook or unavailability of candidates in the OBC-NCL category will be de-reserved and allotted to Open Category candidates in order of merit.

Unfilled seats based on minimum qualifying criterion mentioned in this handbook or unavailability of candidates in the EWS category, SC category and ST categories will not be de-reserved.

The category selected by a candidate at the time of submitting the application form will be final. Requests for any change of category will not be permitted during the later stage of the admission process.

Candidates must note that that benefit of Reservation will be given to them subject to verification of documents. If it is found at any stage that a candidate has used a false/fake/incorrect document or has furnished false/ incorrect/ incomplete information in order to avail the benefit of Reservation, then such a candidate shall be excluded from the subsequent stages of admissions. In case a candidate has already been given admission, then the admission shall stand cancelled.

Candidates should note that the mere appearance in DRT/Interview or being in the rank/merit list neither guarantees nor provides any automatic entitlement to admission to the PhD programme.

### A-1: Reservation for Economically Weaker Section (EWS)

General category belonging to the Economically Weaker Section (EWS) will be a reserved category in which the percentage of Reservation is 10%. The benefit of Reservation will be given only to those General category candidates who satisfy the condition given in the OM No. 20013/01/2018-BC-II dated 17 January, 2021 issued by the Ministry of Human Resource Development, Dept. of Higher Education.

The benefit of Reservation under EWS can be availed upon production of an Income & Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as available on the website <http://admissions.nid.edu> shall only considered valid

- (i) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/ 1<sup>st</sup> Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
- (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
- (iii) Revenue Officer not below the rank of Tehsildar and

- (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

**The date of issue of the EWS certificate must be 1 April 2024 or later.**

Based on the information provided by the candidate in the application form while applying online, will be provisionally allowed to appear for the DRT and subsequent test if shortlisted. To provide / upload valid certificate/s at the time of applying online is the candidate's responsibility.

The verification of the category certificate will be carried out after the DRT. During verification if it is found that the GEN-EWS certificate of the candidate is not valid, then the candidate will be moved to General category, and he/she will be considered as General category candidate for further admissions process.

**On verification at any stage during the admission process or ever after admissions, if the information/document/ certificate found to be incorrect / invalid, the candidature of such candidate will stand cancelled.**

NID's decision will be final and binding. No further communication in this regard will be entertained.

**A-2: Reservation for Other Backward Classes (Non-Creamy Layer)**

The name of the caste must be in the current Central list of OBCs available at: [http://www.ncbc.nic.in/User\\_Panel/CentralListStateView.aspx](http://www.ncbc.nic.in/User_Panel/CentralListStateView.aspx) and the format of the OBC-NCL certificate must be as per the Central format (available on the website <https://admissions.nid.edu> in Download section). The caste of the OBC candidate is mentioned in the state list, but not mentioned in the Central list, such candidates will not be entitled to claim the benefit of Reservation under OBC-NCL category.

**Candidates belonging to the Creamy Layer of OBC are not entitled to apply under reserved category (OBC-NCL) and will have to submit their application under General (unreserved) category.**

Candidates applying under the OBC-NCL or Non-Creamy Layer category are required to produce (upload) a valid certificate in their name in English (**issued after 1 April 2024 or later**) from the relevant competent authorities of their respective state or union territory, certifying that they do not belong to the Creamy Layer along with the final application form. For certificates that are not in the English language, the candidate is required to produce / upload a notarized copy of the English version along with the original copy of the category certificate.

Based on the information provided by the candidate in the application form while applying online, will be provisionally allowed to appear for the DRT and subsequent test if shortlisted. To provide / upload valid certificate/s at the time of applying online is the candidate's responsibility.

The verification of the category certificate will be carried out after the DRT. During verification, if it is found that the OBC-NCL certificate of the candidate is not valid, then the candidate will be moved to the General category.

**On verification at any stage during the admission process or ever after admissions, if the information/document/ certificate found to be incorrect / invalid, the candidature of such candidate will stand cancelled.**

NID's decision will be final and binding. No further communication in this regard will be entertained.

### **A-3: Reservation for Scheduled Caste and Scheduled Tribes:**

The benefit of this Reservation will be given only to candidates belonging to castes and tribes mentioned in the central list published by the Government of India, which can be viewed at the following web links:

Candidates applying under SC and ST categories are required to upload the relevant caste/tribe certificate (in English language only) from the competent authorities of their respective state, union territory or the National Commission of Tribes, valid at the time of applying online. For certificates that are not in the English language, the candidate is required to produce / upload a notarized copy of the English version along with the original copy of the category certificate.

Based on the information provided by the candidate in the application form while applying online, will be provisionally allowed to appear for the DRT and subsequent test if shortlisted. To provide / upload valid certificates at the time of applying online is the candidate's responsibility.

The verification of the category certificate will be carried out after the DRT. During verification if it is found that the SC/ST certificate of the candidate is not valid, then the candidature of such candidates will stand cancelled.

**On verification at any stage during the admission process or ever after admissions, if the information/document/ certificate found to be incorrect / invalid, the candidature of such candidate will stand cancelled.**

NID's decision will be final and binding. No further communication in this regard will be entertained.

### **Appendix B: Reservation for Persons with Disability:**

The benefit of Reservation will be given only to those candidates with disability as described by the Government of India under RPWD Act 2016.

The candidate should submit a Disability Certificate and Unique Disability ID issued by the Department of Empowerment of Person with Disability.

(<http://www.swavlambancard.gov.in>) No other certificate or document will be valid and no representations in this regard will be entertained.

Candidates seeking admission under this category are required to upload the above-mentioned certificate and UDID at the time of applying online.

The verification of the category certificate will be carried out after the DRT. During verification if it is found that the Disability Certificate and UDID of the candidate is not valid, then the candidature of such candidates will stand cancelled under following scenarios:

- If the candidate has availed either compensatory time or services of a Scribe;
- If the candidate has applied as a PwD under GENERAL or GEN-EWS or OBC-NCL

If the candidate has applied as PwD under SC/ST and if his/her Disability Certificate and/or UDID is not valid & has NOT availed compensatory time and/or services of a Scribe, then he/she will be moved to his/her Parent Category (SC/ST). The candidate will be then considered as SC/ST category candidate for further admissions process.

Based on the information provided by the candidate in the application form while applying online, will be provisionally allowed to appear for the DRT and subsequent test if shortlisted. To provide / upload valid certificates at the time of applying online is the candidate's responsibility.

**On verification at any stage during the admission process or ever after admissions, if the information/document/ certificate found to be incorrect / invalid, the candidature of such candidate will stand cancelled.**

NID's decision will be final and binding. No further communication in this regard will be entertained.

## **Appendix C: Application from Foreign Nationals**

- Candidates holding Overseas Citizen of India (OCI) and Person of Indian Origin (PIO) card will have to apply as non-Indian citizens.
- Non-Indian applicants must possess valid passports. Applicants must ensure that their passports are current (not expired) on 1 July 2024, the opening day of NID's 2024-25 academic year.
- Non-Resident Indians (NRIs) holding Indian passports are not eligible to apply under the Supernumerary (Overseas) category and will have to apply for the 12 seats of the main program.
- Candidates will be responsible for obtaining a student visa for India for the entire duration of the programme at NID, before commencement of the programme.
- Seats remaining vacant in the Supernumerary (Overseas) category will lapse and will not be transferred to candidates from any other categories.
- Overseas candidates will also have to appear for DRT and Interviews as per the schedule which will be announced later.
- Non-Indian citizens applying for NID's PhD Program (NOT for the NID-HSLU PhD Cooperation Program) as full-time candidates would have to follow the requirements below:
  - *Foreign nationals with Indian Council for Cultural Relations (ICCR) Fellowship.* Awardees who are sponsored by their respective Governments and awarded a scholarship by the Indian Council for Cultural Relations shall apply for admission through Indian Embassy in their respective countries;
  - *Foreign nationals who are self-financed* shall be granted admission through the Embassy of the respective Governments after approval of the Ministry of External Affairs and a no-objection certificate from the concerned Ministry of the Central Government;
- The medium of instruction at NID is English.

### The SAGE PhD Fellowship (Round 2)

NID is pleased to offer one (1) full-time PhD Fellowship (apart from the 12 seats mentioned) on the topic of “Waste” and material circularity through the SAGE PhD Fellows program of Echo Network of Bangalore, a Denmark-based organisation that works with the Nordic Centre of India to promote research on circularity, Sustainability. Research proposals are invited for this Fellowship opportunity.

The terms of this Fellowship are as follows:

- This Fellowship would be available for research only on the topic of Waste. The research must also relate to the field of Design and thus make a contribution to theoretical knowledge of the two fields (Design and Waste) combined. The proposals for this fellowship should center on material circularity using solid waste, specifically targeting to “Explore a replicable model for a Holistic Waste Management System”. This research will assess innovative design and business models aimed at developing solid waste material circularity systems, such as textile waste in India. Emphasis will be placed on the holistic design of business model research and the development of implementation strategies for solid waste material circularity solutions, ultimately contributing to clean healthy cities by management of household and industrial waste."
- The Fellowship would be available only to **full-time candidates**. The candidate would be required to **fulfil physical attendance requirements at NID's Ahmedabad campus** for the entire duration of their doctoral study.
- The Fellowship is available only to applicants of NID's PhD program, not to applicants of the NID-HSLU Cooperation program.
- The Fellowship would be available for **three (3) years**. If more time is required for the research work to be completed, the candidate could apply for it (extending the duration upto a maximum of 5 years) but the duration of funding is limited to 3 years.
- The fellowship would include a stipend for living expenses in Ahmedabad, tuition fees of the PhD program, and all costs (eg, travel, conferences, material) related to the research being conducted.
- The candidate on this Fellowship is required to **spend up to 7 months in Denmark** (over the three-year Fellowship period) working with Danish institutes associated with Echo Network on this project. The costs of this would be covered in addition to the fellowship.
- Applicants to this Fellowship must clearly **include the following in the title of their research proposals: “Application for SAGE Fellowship”** to indicate their intent of applying for the fellowship. Absence of this phrase in the title would be taken to mean that the applicant does not wish to be considered for the fellowship even if the topic is related to “Waste”.
- Only **one (1) position is available** for the Fellowship.
- Applicants for the Fellowship would **go through the same Admissions process as that published in the Admissions Handbook** for 2024-2025.

The candidate who is awarded the Fellowship would be required to **go through all the academic processes of all doctoral students of NID** during their doctoral tenure at the Institute.
